

## **Privacy statement and cookie policy**

We respect the privacy of visitors to our website and will ensure that the personal information you give us will be treated confidentially. Processing of personal data is done in accordance with the processing of personal data requirements of the Dutch Data Protection Act and the EU General Data Protection Regulation.

### **Purposes of data processing**

We process your personal data for entering into and executing agreements regarding legal services and for managing the resulting relationships, including activities aimed at increasing our customer base. If you fill in our website contact form, or send us an e-mail, the data you send us will be kept for as long as the nature of the form or the content of your e-mail requires for the full response and handling thereof.

### **Click behaviour and visitor data**

Our website keeps track of general visitor data. In this context, in particular the IP address of your computer, any user name, time of retrieval and data sent by a visitor's browser can be recorded and used for statistical analysis of visit and click behaviour on the website. In this way we also try to guarantee optimal functioning of our website.

We try to make this data as anonymous as possible. We do not provide your information to third parties.

### **Google Analytics**

We use Google Analytics to keep track of how users use our website and how effective our Adwords ads are on Google Search Engine Results Pages. The information thus obtained, including your computer's address (IP address), is transmitted to and stored by Google on its servers in the United States. For more information, read both Google's privacy policy, and the privacy policy of Google Analytics.

Google uses this information to keep track of how our website is being used, to be able to provide us with reports about our website and to provide its advertisers with information about the effectiveness of their campaigns. Google may provide this information to third parties if it is legally obliged to do so, or insofar as these third parties process the information on behalf of Google. We have no influence over this. However, Google is not allowed to use the analytics information obtained for other Google services.
